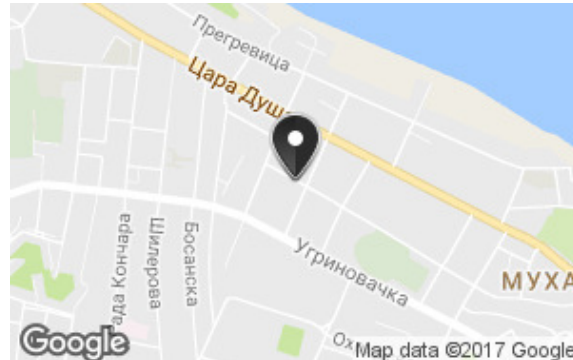
Amendments and cancellations: Until 6 PM local time room will be held without fees, in case of late cancellation or no-show first night will be charged.
